Summer program

This concluded with a largest number of children in our program for a number of years. The staff did an awesome job with a wide range of activities and will provide a yearend summary to our Recreation Committee in writing for our next meeting. They will make some recommendations to help us enhance the program.

Stadium

- Staff A number of projects have been completed this season due to the extra part time staff that we had this past summer. We would like to thank council for their support in this. We were able to complete the softball dug outs, stair wells painted, rooms under bleachers created, 2 broken post fixed at Pride of the Town site, playground equipment will be installed in Goose arm playground as well as a new playground structure in the weights lane section of town. We sometimes as a staff find it challenging with having in summer time to keep up on regular work like grass maintenance, playground inspections, trail inspections, sport field's care. Then we have to factor in Holidays' and then to make ice which requires all staff. The regular day to actives are left undone and becomes a major challenge. With the town growing and new green spaces created in town the extra staff was essential.
- The strawberry festival dance was held here on July 21 and all things went well.
- Humber Valley hockey school was held from July 30- August 11. Numbers were on par with previous years and no major issues.
- Agricultural Fall Fair will be held at complex from September 14&15 and will be hosted by the Humber Valley Grand Lake Economic Cooperation.
- Ice will go on for fall and winter September 29 -2012

<u>Pool</u>

Swimming Lessons Registration - We registered 56 children in Block 1 and 55 in Block 2. This is up 29 children from last year. We were able to offer 8 people private lessons during the regular 2 blocks of regular lessons. These lessons will all be completed Aug 16.

On the week of Aug 20 - 24 we will be offering Bronze Medallion and Bronze Cross training. This training is pre lifeguard courses we have 18 people enrolled

Ladies Washroom Repaired

The work is completed on the Ladies Washroom. Everyone is pleased with the results. We did however have to have half a wall removed and replaced due to excessive mold found in the wall during the removal of the tile.

Evaporator replacement

Next week Dan Spence will be onsite to replace the evaporator for the Dectron Unit. This unit is the air handling unit for the swimming pool and without it we have to deal with excessive Humidity and heat in the pool area and building in general. The unit had to be built and sent to us which has taken 6 weeks. The new evaporator has a coating for marine environment unlike the original unit that was installed.

Bowling alley

Humber Valley Hockey School / Deer Lake Summer Sports / Pasadena Summer Sports: This summer like past summers has been busy in the pool as well as the Bowling Alley with these 3 groups utilizing our facility. We have been able to offer Swimming and Bowling to all groups at the times that they were looking for. With the addition of this we were also able to gain some extra revenue during Hockey School from the general public dropping in to use the Bowling Alley during this 2 week period.

Gazebo/Bandstand

We as a committee feel that we need to install cameras and do major surveillance of these areas. We feel that it is a problem that is getting larger. We feel we will need to lay charges on these sites. They are doing damages to the areas and major littering and have to be stopped. Quotes will be submitted to the committee this week on the proper equipment to do proper surveillance.

Swimming and Boating Safety

Had a concern brought to the committee's attention about safety near the boat launch area and water way. There will be a meeting set up within next few weeks for the general public to come get involved and bring forward some recommendations to enhance safety in the area.
