Your Worship, fellow councillors and members of the gallery, as Deputy Mayor and as Finance Chair for the Town of Deer Lake, it gives me great pleasure to present the Budget for the 2013 taxation year.

I would like to take this opportunity to thank the finance committee, all of council and the members of our management team as we all worked together to bring forth this important financial document and forecast for 2013. All involved played an important role in this balanced budget of \$6.5 million.

Before I proceed with this year's budget I would like to highlight some of the great investments in capital that we were able to acquire this year. We have purchased a beach cleaner that will help keep one of our greatest assets, our beautiful beach, an even more wonderful place to visit. An asphalt recycler has been purchased to help repair our roads at a lower cost. And finally we purchased a new tandem dump truck to help keep our road safe during the winter. Some of the capital works projects in town that have been worked on were paving on Wellon Drive (Industrial Park), finishing Birch and Colburne, paving Trailer Court Road, and Wight's Road and installing waterlines and paving on Garden Road. Also our town hall received a much needed new roof.

I would also like to bring to everyone's attention the incredible growth that has taking place in our community during the last year; with forty-four new residential dwelling and five new commercial buildings, one being the opening of the new Holiday Inn Express. It is easy to see that Deer Lake is a vibrant community which we all should be proud of.

Now on to our upcoming year!! I know there were great concerns about the mill rate due to the increase of the assessed values of everyone's homes. I am very pleased to announce at this time that the Town of Deer Lake will be reducing the mil rate as of January 1^{st} , 2013 from 8.5 mils to 7.5 mils.

Some of our budget highlights include:

- The Town is committed to debt reduction and many of our long-term loans will be paid off during this year. This debt reduction will increase the town cash flow causing operations to run smoother.
- We are pleased to announce Capital Works commitments to Middle Road and Gatehouse Road. Also with our gas tax funding, critical areas of town will be reviewed and repaired under a priority level. A few areas that we will be looking at are Reid's Lane, Seventh Avenue and Elizabeth Avenue. Also this year we will be doing some much needed repair to the Fire Hall Roof.
- Our Public Works Department will be purchasing a new backhoe. To further aid in ensuring efficient operations of our town, this budget allows a further commitment to sidewalk development.

• The Budget of 2013 has emphasis on targeting wellness for the residents of Deer Lake and on the visiting public. Work will be done on Bennett's Avenue Sports field road. We will construct a new beach volleyball court, boards will be replaced at the stadium and new lifeguard chairs will be installed at the pool. Also canopies will be installed over doorways at the recreation complex insuring safety for everyone who uses it. In continuing to promote the use of the Hodder Memorial Recreation Complex and through our cultural and festivals fund, we are committed to the social and economic welfare of our residents.

Councillors will not be receiving an increase in remuneration – there has been no increase in remuneration rates for members of council of the Town of Deer Lake for about the past 12 years.

The budget of 2013 also sees a further commitment to assist our low income families with our sliding scale for those residing in their homes and earning \$0 to \$17,000, a \$2,000.00 raise of the exemption level from last year. We will continue to assess them on a case-by-case basis defining where they fit on our scale. Furthermore, as noted above, there will be NO increases in water and sewer rates

Interest on delinquent accounts annual rate will stand at 12 per cent and we will be offering residents a ONE MONTH ONLY discount of three per cent if all accounts current and arrears are paid by January 31, 2013.

Note: All taxes due and payable March 31, 2013. For those delinquent accounts, staff have been instructed to be firm and vigorous in collecting arrears as we need 100 % collections to operate our town in the most efficient and effective manner.

Town of Deer Lake Council has passed a resolution supporting a national campaign to make sure municipal priorities are reflected in the federal government's new long-term infrastructure plan.

Almost \$2 billion dollars a year in federal infrastructure finding will end when the Building Canada Plan expires in March 2014. Any interruption in this funding could have serious consequences for the Town of Deer Lake, including water and sewer for Middle Rd, Garden Road, First Avenue and Second Avenue, sidewalks and storm drains for Nicholsville Rd and upgrades to lift stations.
