Construction of a concrete wheelchair assessable pad at the entrance to Deer Lake Beach. The area is located off Nicholville Road at Joe Butt's Lookout.

- Work can begin any date after June 13 but all work must be completed by June 23.
- The area consists of 500 sq feet 4 inches thick of stamped concrete with a wooden plank look.

- *Supplying all equipment.*
- *Mobilization and Demobilization of all equipment*

- *Guidance to the contractor on the work to be completed.*

- *Removal of flag stone, stone bench, table*
- *Replacement of sod around perimeter of concrete*
