The following regulatio; ns have been made by the Town Council of Deer Lake under the provisions of the Local Government Act, 1972, and were approved by me on the 6th day of December A.D., 1979.

REGULATIONS

- 1. <u>Interpretations</u>: In these regulations except where the content otherwise requires:
 - (a) "Act" means the Local Government Act, 1972.
 - (b) "Town" means the Town of Deer Lake as defined by Order-in-Council dated the 27th day of May, A.D., 1950, and any amendments thereto, and made under the provisions of the said Act.
 - (c) "Council" means the Town Council of Deer Lake.
 - (d) "Livestock" means any domestic animal including fowl but shall not be held to include cats or dogs.
- No person shall keep on any property within the Town, owned by him, or rented or otherwise under his control, any livestock of any discription, without the written permission of Council.
- 3. When livestock has been brought into the Town in violation of these regulations, the Council may order the owner to remove or destroy the said livestock, and if the owner fails to do so within the time limit set by Council, the livestock may be seized by the Council and destroyed immediately or sold, and any person appointed by the Council may enter any premises for the purpose of seizing or removing the said livestock.

- 4. Any person who prevents or attempts to prevent an employee of the Council from seizing livestock shall be guilty of an offence.
- 5. Prosecution under these regulations may be taken summarily by any Police Constable or any employee appointed by the Council.
- 6. Any person who violates any of the provisions of these regulations shall be guilty of an offence and shall be liable on a summary conviction to a fine not exceeding one hundred dollars and in default of payment of such fine to imprisonment for a period of not exceeding ninety days.
- 7. These regulations shall come into effect on the day of A.D., 1979, and may be cited as the Town of Deer Lake (Control of Livestock) Regulations, 1979.

The following regulations have been made by the Town Council of Deer Lake under the provisions of the Local Government Act, 1972, and were approved by me on the day of Act, A. D., 1976.

REGULATIONS

- 1. Interpretations. In these regulations unless the context otherwise requires:
 - (a) "Act" means the Local Government Act, 1972.
 - (b) "Council" means the Town Council of Deer Lake constituted under the provisions of the said Act.
 - (c) "Town" means the Town of Deer Lake as defined by paragraph 2 of of Order-in-Council, dated the 27th day of May, A.D., 1950.
 - (d) "Animals" means horses, pigs, cattle, sheep and goats, but shall not be held to mean dogs or cats.
- 2. No person shall keep any animals within the Town except in areas designated for the purpose of farming or for the raising of animals for domestic or commercial use.
- 3. Any person who violates any provision of these regulations shall be guilty of an offence and shall be liable on summary conviction to a penalty not exceeding one hundred dollars or in default of payment thereof to imprisonment for a term not exceeding Ninety (90) days.
- 4. These regulations shall come into effect on the day of Nov A.D./976

 1976, and may be cited as the Town of Deer Lake (Keeping of Animals) Regulations,

 1976.
