  - 4) \$10,000.00 Swimming Pool Restart Grant
- The Director of Operations and Communication the Recreation Department are looking in to The Community Resilience Infrastructure Funding for the Arena.

• Recreation will attempt to fence the compost site this fall weather and time depending. This will keep residents from dropping compost off in the wrong areas.

#### Arena update

- We have made some changes providing extra seats under the bleachers for skaters in Minor Hockey and Figure Skating to put on their skates. This seams to have made it better for all concerned. We have a full slate of Minor Hockey, Figure Skating and Rec Hockey as in previous years. With the addition for the Extra Stadium attendant we are able to abide by the Guidelines for the cleaning of the Arena between skates.
- Arena staff has been busy moving things from the Gymnastic side of the storage unit. They began on Monday November 2.
- Counsellor Freake has renewed discussion with the Treehouse of the possibility of them hosting the preschool skate on Thursday afternoons. This would make it more exciting for the children and would draw more revenue to the arena.
- Recreation has received a request from a minor hockey parent asking if it was a possibility
  of having a camera installed at the arena for parents and grandparents that can not come
  to the arena because covid regulation during minor hockey practice. They wanted to know
  if we could stream the camera live during minor hockey. Recreation has checked with
  computers and communications; this is something we can do as long as the software will
  with a Minor Hockey's schedule. Minor Hockey has been contacted to see if there are any
  privacy issues and they're looking into it.

### **Bowling Alley Update**

 The Bowling Alley Leagues are running Monday to Thursday night with the exception of Sunday Night League. They did start but could not get enough interest with the fear of Covid and will try again after Christmas.

### **Swimming Pool Update**

• The Swimming pool is in the last 2 weeks of the 8-week swimming program with 146 enrolled. We have aquafit classes Monday, Wednesday and Friday Mornings as well as Tuesday and Thursday nights. We have a private aquafit class booked every Monday afternoon for a group of Pasadena seniors. There is a time slot booked for the community of Cormack which was paid for before Covid began Each Sunday evening and we have a Deer Lake Power swim time slot booked for each Saturday evening.
