To align with the Policy on COVID-19 Vaccination for the Town of Deer, the vaccination requirements of the COVID-19 Vaccination Policy for Supplier Personnel applies to all new and existing Town of Deer Lake contracts that involve services (including goods contracts that have a services component and construction services) where, in order to perform the work, supplier personnel Town of Deer Lake workplaces (i.e., places of work owned or operated by the Town of Deer Lake) where they may come into contact with Town of Deer Lake employees and/or residents.
