(1) A swimming pool on a residential property, which exceeds 0.9 metres in depth and is permanently or temporarily located outdoors, shall be fully enclosed or fenced.						
(2) A swimming pool fence shall be:						
(a) No less than 1.8 metres in height,						
(b) Constructed and maintained so as to completely surround the swimming pool area of the lot,						
(c) Located no closer than 1.8 metres to any portion of the pool,(d) Constructed so as to obstruct any vision of the pool from outside the fence,						
(e) Constructed so as to prevent unauthorize						
(f) Secured with an impassable locked gate whenever the pool is not being monitored by the owner or a representative of the owner. (3) The requirements of Paragraph (2) shall also apply to hot tubs, except where the hot tub is equipped with a locking cover that is kept locked
