PUBLISHED BY AUTHORITY PARKING (Snow)

Pursuant to authority delegated by the Minister of Works, Services and Transportation under Section 189 and 190 of the Highway Traffic Act, R.S.N. 1990, c,H-3 and all other powers enabling it in this behalf, the Town Council of Deer Lake has made the following regulations.

REGULATIONS

- 1. <u>Interpretations</u>: In these regulations unless the context otherwise requires:
 - (a) "COUNCIL" means the Town Council of Deer Lake
 - (b) "TOWN" means the Town of Deer Lake defined by paragraph 2 of Order-in-Council dated the 27th day of May A.D., 1950 and made under the provisions of the Local Government Act.
 - (c) "HIGHWAY" means the entire width between the boundary lines of a highway, road, street, avenue or thoroughfare, and for the purpose of these regulations is intended to be defined in Section 2, subsection (ff) of the Highway Traffic Act.
 - (d) "DRIVEWAY" means a clearly defined private road, way, drive, path or passage or a like opening which is wide enough, but whereby the owner, occupier or user of a property has vehicular access from a roadway to a point within the property.
 - (e) "PARKING LOT" means a clearly defined area of land provided by the owner, occupier or user of a business premises for the use of the general public for the parking of motor vehicles.
 - (f) "VEHICLE" means a device in or upon which a person or property may be transported or drawn upon a highway.
 - (g) "STREET RESERVATION" means the land reserved for the public road, street, lane, sidewalk or public way.
- 2. During the period from the first (lst) day of December in each year to the thirtieth (30th) day of April in any succeeding year, both days inclusive, no person shall park an unattended vehicle upon any street reservation within the Town between the hours of 12:00 midnight and 8:00 a.m.

- 3. At any time during a snow storm and for the twelve hours thereafter no person shall park an unattended vehicle on any street reservation within the Town.
- 4. Any unattended vehicle parked on an y street reservation within the Town in contravention of the regulations may be removed and impounded by the Council, and the cost of such removal and impounding may be recovered from the owner as a civil debt.
- 5. During the period from the first (1st) day of December in each year to the thirtieth (30th) day of April in any succeeding year both days inclusive, no person shall shovel, plough, cause to be shoveled or ploughed any residue snow from a driveway or parking lot unto any highway within the municipal boundaries of the Town of Deer Lake controlled by the Town Council of Deer lake.
- 6. (a) Any person who violate Section 2 of these Regulations shall be guilty of an offence and shall be liable on summary conviction to a penalty of not less than \$20.00 and not more than \$100.00 or in default of payment of such penalty to imprisonment for a term not exceeding 90 days.
- 6. (b) Any person who violates Section 5 of these Regulations shall be guilty of an offence and shall be liable on summary conviction to a penalty of not less than \$100.00 and not more than \$500.00 or in default of payment of such penalty to imprisonment for a term not exceeding 90 days.
- 6. (c) Any person who viloates any of the provisions of these Regulations, other than Section 2 or Section 6, shall be guilty of an Offence and shall be liable on summary conviction to a penalty not exceeding \$100.00 or in default of payment of such penalty to imprisonment for a term not exceeding 90 days.
- 7. Prosecution under these regulations may be taken summarily by Council or any Council Employee, specifically authorized by the Council and by any police constable.

- 8. These regulations shall come into effect on the 16 day of July A.D., 1993, and may be cited as the Town of Deer Lake (Snow Clearing) Regulations, 1993.
- 9. The Town of Deer Lake (Snow-Clearing) Regulations dated the 16th. day of January , A.D., 1976, are hereby repealed.
