#### **NOISE AND NUISANCE BY-LAW**

Pursuant to the authority conferred by sections 7 and 8 of the Towns and Local Service Districts Act (TLSDA), the town of Deer Lake has adopted, through resolution of the Town Council of the Town of Deer Lake on the day of , A.D. 2025 the following Noise and Nuisance By-Law.

#### **By-Law Statement**

The purpose of this By-Law is the regulate, manage and enforce situations within the Town of Deer Lake that substantially and unreasonably interferes with an individual's right to peace, privacy, and enjoyment of property. It seeks to establish clear and enforceable standards for acceptable noise levels by specifying prohibited noise sources, times and locations.

#### 1. Title

This By-Law may be cited as the Town of Deer Lake Noise and Nuisance By-Law.

#### 2. Definitions

- (a) "Act" means the Town and Local Service Districts Act
- (b) "Council" means the Municipal Council of the Town of Deer Lake.
- (c) "Town" means the Town of Deer Lake as defined in paragraph 2 of the Order-In-Council dated the 27<sup>th</sup> day of May, A.D. 1950, and made under the provisions of the Act.
- (d) "By-Law Enforcement Officer" for the purpose of these regulations means a peace officer with powers as outlined in the Act and who is appointed by Council with powers to enforce the Town of Deer Lake's Animal Control By-Laws.
- (e) "Town Clerk" means the town clerk of Deer Lake
- (f) "Statutory Holiday" shall mean a holiday identified in the Shops Closing Act, RSNL 1990, S-15 as amended.
- (g) "Weekday" shall mean Monday through Friday, exclusion of any Statutory Holiday.
- (h) "Noise Nuisance" refers to a sound that is disturbing, disruptive or harmful to the well being of individuals or the community.

#### 3. Noise and Nuisances Application

1. No person shall make, continue or cause to be made any loud, unnecessary, excessive or unusual noise or participate in any raucous behaviour that annoys, disturbs, injures, or disrupts the comfort,

- well-being, peace and safety of an individual or the community within the limits of the Town, except in accordance with this By-Law.
- 2. No person shall, within the limits of the Town, operate, cause or allow to be operated any public address system, gramophone, radio or any other device used to reproduce or amplify sound where the sounds are capable of being heard on any street in the Town without first having received approval from Council.
- 3. No person shall create a noise within the limits of the Town, through the use of Firearms or other similar noise making devices, except as may be approved by Council or other Law Enforcement Agencies.
- 4. No person shall deposit, throw, sweep or place litter or garbage upon any highway or sidewalk within the limits of the town or on any other public property. This does not include garbage for garbage pick up.
- 5. No person shall, within the limits of the town use a lawnmower, chainsaw, or any other machinery or equipment which may disturb the peace and quiet of a neighbourhood, between the hours or 12am and 7am on a weekday, Saturday, Sunday or a statuary holiday, except as required for snow removal purposes.
- 6. No person, firm or corporation shall permit or maintain a nuisance by creating loud noises and/or raucous sounds or by creating or participating in any raucous behaviour that, in the opinion of Council, may have an unpleasant or undesirable effect on the senses.
- 7. No person shall keep or maintain, or permit to be kept or maintained upon any premises owned, occupied or controlled by any person, any animal or animals, which by frequent or long continued noise disturbs the peace and quiet of any person.
- 8. No person shall create or allow any noise caused by construction, excavating, repairing, altering or demolishing any building or structure by the removal, transport or delivery or rock, gravel or sand or other materials between the hours of 12am and 7am on a weekday, Saturday, Sunday or a statuary holiday.
- 9. No person shall use any off road, all terrain or motorized snow vehicle except where such use is approved and authorized under the Off-Road Vehicles Act.

## **Exceptions**

Sounds caused by the following are exempt from the prohibitions set out in this By-Law.

- 1. The sounding of any bell, horn, siren or other warning device of any vehicle where the law required, or when responding to an emergency.
- 2. The sound of snow clearing equipment while preforming cleaning duties.
- 3. The ringing of church bells or chimes.
- 4. The sounding of motor vehicle horns in a wedding procession or a parade as approved by Council.
- 5. The sound of a portable generator in a residential area in the event of a power outage.
- 6. Amplified sound and or fireworks during events staged on or on behalf of the Town.
- 7. The operation of privately owned snow blowers or other forms or privately owned snow clearing equipment used for the purpose of providing vehicle access into or out of a private driveway.

#### 4. Offences and Penalties

- 1. Every person who is guilty of an offence under this By-Law, or who acts on contravention of or fails to comply with any provision thereof, or neglects or refuses to do so:
  - (a) May be liable to penalties as stipulated in accordance with section 290 of the Towns and Local Service Districts Act; or
  - (b) May be subject to an order under section 285(1) of the Towns and Local Service Districts Act; or
  - (c) May be subject to a violation notice issued under section 287(1) of the Towns and Local Service Districts Act; or
  - (d) May be issued a ticket under the Provincial Offences Act in accordance with section 288 of the Towns and Local Service Districts Act.
- 2. Any person doing any of the acts outlined in section 298 of the Towns and Local Service Districts Act is considered to have committed an offence.

#### 5. Severability

If a court of competent jurisdiction should declare any section or part of a section of these By-Laws to be invalid, such declaration shall not affect the remainder of these By-Laws and the remainder shall remain valid and in force.

#### **ANIMAL CONTROL BY-LAWS**

#### **By-Law Statement**

The purpose of this By-Law is to ensure the health, welfare and safe keeping of animals in the Town of Deer Lake. It outlines the roles and responsibilities of the Animal Owner/s, By-Law Enforcement Officers and the RCMP/RNC.

## 1. Title

These By-Laws may be cited as the Town of Deer Lake Animal Control By-Laws

#### 2. Definitions

In these By-Laws unless the context otherwise requires:

- a. "Act" means the Town and Local Service Districts Act
- b. "Council" means the Municipal Council of the Town of Deer Lake.
- c. "Town" means the Town of Deer Lake as defined in paragraph 2 of the Order-In-Council dated the 27<sup>th</sup> day of May, A.D. 1950, and made under the provisions of the Act.
- d. "By-Law Enforcement Officer" for the purpose of these regulations means a peace officer with powers as outlined in the Act and who is appointed by Council with powers to enforce the Town of Deer Lake's Animal Control By-Laws.

- e. "Town Clerk" means the town clerk of Deer Lake
- f. 'Premises" for the purpose of these By-Laws will be deemed to mean land and all buildings with the exception of residential buildings.
- g. "Dog" means a male or female dog or puppy and includes an animal which is a cross between a dog and a wolf.
- h. "Injured / Injury" includes, but is not limited to injuries caused by wounding, worrying, terrifying or pursuing.
- i. "Kennel" means an establishment for the keeping, breeding or boarding of Dogs or Cats for commercial purposes.
- j. "Owner" a person who has custody, charge or possession of an animal or who is the owner of a property, a house, or premises or part of a premises where an animal is kept or permitted to live or remain.
- k. "Running at Large" means to be unleashed in a public place or on a premises not owned by or in the possession of the owner of the animal.
- I. "Cat" means a member of any breed of domesticated feline or crossbreed of domesticated feline whether spayed or neutered.
- m. "Live Trap" means a cage like device used in the capture of cats without injury to the animal
- n. "Animal" means cat or dog as defined in section 2(g) and (l) for the purpose of this regulation.
- o. "Puppy/Kitten" means a domesticated dog or cat less that 6 months old.
- p. "Stray Cat" means cats that have been born in captivity, were socialized to humans at one time in their lives and were domesticated.
- q. "Feral Cats" means cats born in the wild and have at no time been socialized with humans.
- r. "Feral Dogs" means dogs that have been either abandoned of were born in the wild and have never been socialized with humans.

#### 3. Application

- 1. No person shall keep any animal other than a puppy or kitten, not more that 4 months old, within the limits of the Town, unless a licence has been issued by the Council allowing the owner to own a licenced animal and unless such animal has a numbered tag or plate indicating that such a licence is in force.
- 2. The Town shall keep a register of all animals licenced to them.
- 3. No person shall lead, have or take an animal into any public place in the Town unless such animal has a numbered tag or plate indicating that a licence has been issued to the owner by the Town.
- 4. (a) The licence shall be issued for the lifetime of the owner
  - (b) Licence tags shall be issued at no cost to the owner for the first tag, subsequent tags shall be at a cost of \$10.00 each
  - (c) The owner of every licenced animal shall, on receipt of the licence tag, attach it to a collar around the animal's neck.
- 5. Any animal found at large in the Town contrary to these By-Laws may be euthanized by a licenced veterinarian at the request of the By-Law Enforcement Officer at the expiration of five (5) days excluding weekends and holidays, after the time of impounding.

- 6. Any court of Summary Jurisdiction may take cognizance of a complaint that an animal is dangerous and not kept under proper control or has bitten or attempted to bite any person, and if it appears to the court that the animal is dangerous or has done any of the things referred to herein, the court may order the owner to euthanize it
- 7. The owner of an animal who fails to comply with an order made under this section shall be deemed to have committed an offence in terms of these By-Laws.
- 8. No person shall establish a kennel or carry on any business or institution for boarding, keeping, training, breeding or treating animals unless the permission of the council, in writing, has been obtained therefore.
- 9. (a) the owner of an animal shall keep it safely tethered, penned or contained at all times.
  - (b) Notwithstanding subsection (a) an animal need not be tethered, penned or contained where
    - i. It is held on by a leash by a person capable of controlling and restraining its movement.
    - ii. It is kept/used for another purpose not and under condition not prescribed in the By-Laws.
- 10. If any animal bites any person other that its owner or a member of its owner's household and while not in its owner's premises, such animal shall be deemed to be a nuisance and the owner thereof shall be deemed to have committed an offence in terms of these By-Laws.
- 11. If any animal causes damage to any lawn, grass plot, garden or flower bed or flower shrub or plant, such animal shall be deemed to be a nuisance and the owner thereof shall be deemed to have committed an offence in terms of these By-Laws.
- 12. If an animal defecates on any public or private property other that the property of its owner, the owner shall remove such defecation immediately, this includes town parks, streets, sidewalks, boardwalks, trails, beach and any other private and public lands other than that of the owner. If such defecation is not removed the owner of such animal shall be deemed to have committed an offence in terms of these By-Laws. This section shall not apply to persons using seeing animals.
- 13. If any animal barks or howls in such a manner as to disturb the peace or constitute a nuisance or annoyance to residents in the neighbourhood, such animal shall be deemed to be a nuisance and the owner deemed to have committed an offence under these By-Laws.
- 14. Whenever an animal is found in any public place or on any private property without the consent of the owner, occupant, or person having control of such private property or without a tag as required by this By-Law, or is not accompanied by its owner held securely by a leash, the By-Law Enforcement Officer shall and may impound the animal.
- 15. The owner may recover an impounded animal by contacting the Deer Lake Town Office and making arrangements, they must provide proof of ownership and pay any associated impound fees.
- 16. The following Seizing and Impound fees shall be paid by the owners of animals seized or impounded:
  - (a) Seizing and Impounding 1st offence.....\$100.00
  - (b) Seizing and Impounding 2<sup>nd</sup> offence.....\$200.00
  - (c) Seizing and Impounding 3<sup>rd</sup> offence......\$300.00
  - (d) Daily fee for each day animal held in pound......\$25.00

#### 17. (a) No person shall:

- I. Tease An animal caught in an animal trap
- ii. Throw or poke any object into a trap when an animal is trapped therein

- (b) Any person setting an animal trap shall:
- i. Be responsible for contacting the By-Law Enforcement Officer. If a cat/animal is trapped after hours, it is the responsibility of the person setting the trap to house the cat/animal in a comfortable manner and provide food and water.
- ii. Shall be given instructions on how to use the trap.
- iii. Check the trap hourly, if the trap cannot be checked hourly it must be rendered harmless
- iv. Cat traps can be used for a maximum of 84 hours, after which time the By-Law Enforcement Officer will collect the trap.
- 18. (a) When an animal, which bears a numbered tag, as required by these By-Laws has been impounded, the owner of the animal shall be given notice. If the animal has not been redeemed by or on behalf of the owner within three(3) days excluding weekends and statutory holidays, after the dispatch of such notice the By-Law Enforcement Officer shall have the animal disposed of, euthanized or turned over to the SPCA.
  - (b) When an animal does not bear a numbered tag, as required by these By-Laws, has been impounded, the By-Law Enforcement Officer shall have the animal disposed of, euthanized or turned over to the SPCA after the expiration of 72 hours, excluding weekends and statutory holidays.
  - (c) Where, in the sole discretion of the By-Law Enforcement Officer and the SPCA staff, an animal liable to be impounded, appears to be vicious, dangerous, diseased or otherwise unfit for impounding, the By-Law Enforcement Officer, in consultation with the Veterinarian, may cause the animal to be disposed of or euthanized forthwith.
- 19. The By-Law Enforcement Officer, shall have the right to seize any animal within the town limits which in their opinion appears to be mistreated.

#### 4. Enforcement

- 1. The Town Council of Deer Lake, or its authorized administrator, shall be the enforcement authority for the purpose of these By-Laws.
- **2.** Any person who interferes with or attempts to interfere with a By-Law Enforcement Officer, in the exercise of their duties, shall be deemed to have committed an offence in terms of these By-Laws.
  - (a) Any person who, without authority of the By-Law Enforcement Officer, releases any animal that has been impounded, shall be deemed to have committed an offence in terms of these By-Laws
  - (b) Every person requested by the By-Law Enforcement Officer, and or SPCA, shall, on request, forthwith give his/her name and address.
- **3.** Enforcement and prosecution under these By-Laws may be undertaken by any Peace Officer, Police Officer, or by any other person so authorized by Enforcement Authority.

**4.** Any cost to the Town for all works carried out in response to a violation of these By-Laws, in addition to any penalty prescribed hereunder, may be recoverable from the owner or the person in contravention of these By-Laws as a civil debt.

#### 5. Offence and Penalties

- 1. Every person who commits an offence under these By-Laws or who acts in contravention of or fails to comply with any provision thereof, or neglects or refuses to do so:
  - (a) May be liable to penalties as stipulated in accordance with section 290 of the Town and Local Service Districts Act; or
  - (b) May be subject to an order under section 285(1) of the Town and Local Service Districts Act; or
  - (c) May be subject to a violation notice issued under section 287(1) of the Town and Local Service Districts Act; or
  - (d) May be issued a ticket under the Provincial Offences Act in accordance with section 288 of the Town and Local Service Districts Act.
- 2. Any person doing any of the acts outlined in section 298 of the Town and Local Service Districts Act is considered to have committed an offence.

#### 6. Severability

If a court of competent jurisdiction should declare any section or part of a section of these By-Laws to be invalid, such declaration shall not affect the remainder of these By-Laws and the remainder of these By-Laws shall remain valid and in force.

#### 7. Appeals Process

- An appeal of any section or part of this By-Law can be made, in writing to Council.
- Persons wishing to plea "Not Guilty" to an offence must do so no later than the default conviction
  date stated on the ticket. Persons must complete the required information on the ticket and send it
